Respected Mam,

I, Suresh Pratap Singh, am a student of BA 5<sup>th</sup> sem in your college. I want to bring your attention towards recent series of events. On the day of college trip to Kasauli (i.e. 8<sup>th</sup> Oct), Ms. Valisha Sharma, student of B.A. 1<sup>st</sup> year was the reason Mr. Almar Khan (her boyfriend) along few outsiders followed the buses to trip destination. They had breakfast together. Meanwhile, a student argued with a professor about changing bus. On reaching destination, a professor asked me who argued, I told him by pointing the student out. Salman Khan (outsider brother of Almar Khan, was standing behind me who informed Almar horrendously that I had complained about them to professors.

Later, on 19<sup>th</sup> Oct, at 3pm approximately when I was about to go home Almar came to college and asked me if I had complained about him. On asking who said so. He told his brother who was standing behind me saw me complaining to professors. Then he said to meet his brother who was outside PIMT (also under aegis of GRESWT) canteen to clear misunderstanding but they were ready with gang and had beaten me up but my friends rescued me and Almar with his gang ran away.

On 20<sup>th</sup> Oct at 11am, when we were in canteen during free period. Valisha called me to meet her. I told her my whereabouts and she came to canteen and asked to apologise to Almar as she believed I had complained about them. I straight away refused and told her I did not say anything about them. She slapped me across face in front of all present in canteen when she was about to slap again I tried to defend myself by stopping her hand. Then I went to reception to seek

help from faculty for this case and found Sr Tejinder Singh and told him whole scenario in registrar office but he was called by you so he left urgently

During that I was getting continuous calls from my classmate and he called me outside to resolve this matter. So, I went outside and saw Valisha going back to college. Akmal abruptly started abusing me. He and his friends again beat me badly, my friend rescued me and we ran back to college. Later, I came to know it was Valisha who plotted all this and asked them to beat me up again.

I was wronged in many ways physically and mentally due to Valisha Sharma. I hereby seek redressal, requesting you to take strict action against Valisha Sharma who caused all this chaos and has a bad reputation for violating college norms earlier too.
