DIRECTIVES ON ANTI-RAGGING

The Directives on Anti-Ragging in Gobindgarh Public College, Alour, Khanna are here being farmed under the guidelines of University Grants Commission. New Delhi.

'RAGGING' Means the Following:

Any conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which cause or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

UGC ANTI-RAGGING REGULATIONS (Clause 3, 7, 9.1)

CLAUSE 3

What constitutes Ragging? - Ragging constitutes one or more of any of the following acts:

- a. any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- b. indulging in rowdy or indiscipline activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- c. asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
- d. any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
- e. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- f. any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- g. any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;

- h. any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student;
- i. any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

CLAUSE7

Action to be taken by the Head of the institution.- On receipt of the recommendation of the Anti-RaggingSquad or on receipt of any information concerning any reported incident of ragging, the Head of institutionshallimmediately determine if a case under the penallaws is made out and if so, either on his own or through a member of the Anti-Ragging Committee authorized by him in this behalf, proceed to file a First Information Report (FIR), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one ormore of the following, namely;

- i.Abetmenttoragging;
- ii. Criminalconspiracytorag;
- iii. Unlawfulassemblyand riotingwhileragging;
- iv. Publicnuisancecreatedduringragging;
- v. Violationofdecencyandmoralsthroughragging;
- vi. Injuryto body, causing hurt or grievous hurt;
- vii. Wrongfulrestraint;
- viii. Wrongfulconfinement;
- ix. Useofcriminal force;
- x. Assaultaswellassexualoffencesorunnaturaloffences;
- xi. Extortion;
- xii. Criminaltrespass;
- xiii. Offencesagainstproperty;

- xiv. Criminalintimidation;
- xv. Attemptstocommit anyorallof theabove-mentioned offencesagainstthevictim(s);
- xvi. Threattocommitanyor alloftheabove-mentionedoffencesagainstthevictim(s);
- xvii. Physicalorpsychologicalhumiliation;
- xviii. Allotheroffencesfollowingfromthedefinitionof"Ragging".

Provided that the Headof the institution shall forthwith report the occurrence of the incident of ragging totheDistrictLevelAnti-RaggingCommitteeandtheNodalofficeroftheaffiliatingUniversity,iftheinstitutionis an

affiliated institution.

Provided further that the institution shall also continue with its own enquiry initiated under clause 9 of theseRegulations and other measures without waiting for action on the part of thepolice/local authorities and such remedial action shall be initiated and completed immediately and in no case later than a period of sevendaysof thereported occurrence of their cident of ragging.

CLAUSE9.1

The institution shallpunisha studentfoundguilty ofragging after following the procedure and in the manner prescribed herein under:

- a) The Anti-Ragging Committee of the institution shall take an appropriate decision, in regard to punishmentor otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of raggingestablished in the recommendations of the Anti-Ragging Squad.
- b) The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, namely;
- i. Suspensionfromattending classes and a cademic privileges.
- ii. Withholding/withdrawingscholarship/fellowshipandotherbenefits.
- iii. Debarringfromappearingin anytest/examination orotherevaluation process.
- iv. Withholdingresults.

- v. Debarringfromrepresentingtheinstitutioninanyregional,nationalorinternationalmeet,tourn ament,youthfestival,etc.
- vi. Suspension/expulsionfromthehostel.
- vii. Cancellationofadmission.
- viii. Rusticationfromtheinstitutionforperiod rangingfromonetofoursemesters.
- ix. Expulsion from the institution and consequent debarring from admission to any other institution for aspecified period. Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.
- c) An appealagainst the order of punishment by the Anti-Ragging Committee shall lie,
- i. in case of an order of an institution, affiliated to or constituent part, of a University, to the Vice-Chancellorofthe University;
- ii. incaseofanorder of a University, toits Chancellor.
- iii. in case of an institution of national importance created by an Act of Parliament, to the Chairman orChancellorof theinstitution, as the casemaybe.

MEASURES UNDERTAKEN BY GOBINDGARH PUBLIC COLLEGE, ALOUR, KHANNA TO ENFORCE ANTI-RAGGING REGULATIONS

- The college has a functional Anti-Ragging Committee consisting of the Principal as
 its chairperson; a Teacher Convenor, Teacher Members, Male and Female
 Students as members.
- College Prospectus is a first-hand information and message for students to make GPC
 a ragging free campus and provides information regarding the procedure of lodging a
 complaint for any incidence of ragging.
- 3. The admission form contains a declaration by the student for not indulging into any kind of ragging and such activities and this form is duly signed by the student and his/her parent.
- 4. During induction program, the new comers are provided detailed information regarding the Anti-ragging committee and the procedure of lodging a complaint for any incidence of ragging.
- 5. Canteen, parking, College Notice Board and other significant places in the college have notices bearing the slogan "Ragging is Banned".
- 6. College has Installed CCTV cameras and faculty members are assigned regular Proctoral Duties to maintain discipline and deter ragging activities.
- 7. Any student who becomes victim of ragging has full right to lodge a complaint with the Anti-Ragging Committee for proceedings to be initiated within the next 2 Hours.
- 8. Students can drop a written complaint against ragging in the Complaint Box located in the Administrative Block.
- 9. Complaint of ragging can be lodged online also.
